



Tuition Contract 2025-2026

Participation Tuition - Families fulfill all requirements

1. Families are active members of St. Veronica Parish. Families support the parish with their time, by attending Mass regularly, with their talent by serving in parish ministries, and with their treasure by donating to weekly collections, the Archdiocese Annual Appeal, and any Capital Campaign.
 2. Families log at least thirty (30) hours of service by April 30, 2026. Families support all school fundraisers by contributing time, talent, or treasure.
 3. Families log an additional (5) hours of service to be worked at the Parish Festival, on the day(s) of the Festival (NB: attendance planning sessions do not count toward this requirement)
 4. Families attend all mandatory school meetings, plus at least two School Guild or Men's Club meetings. Each meeting attended is worth 1 service hour.
- **One Child** \$9,984 / annually -or- \$832 per month for 12 month (July – June)
 - **Two Children** \$17,124 / annually -or- \$1,427 per month for 12 months (July – June)
 - **Three or More** \$22,848 / annually -or- \$1,904 per month for 12 months (July – June)

Non-Participating Tuition - Families don't fulfill any requirements

- **One Child** \$11,508 / annually -or- \$959 per month for 12 month (July – June)
- **Two Children** \$23,220 / annually -or- \$1,935 per month for 12 months (July-June)
- **Three or More** \$34,836 / annually -or- \$2,903 per month for 12 months (July – June)

Additional Tuition Information

- Your fulfillment of your 2025-2026 Tuition Contract will determine your tuition tier for the 2025-2026 school year.
- **If families fail to fulfill the requirements of their selected tuition tier by April 30, 2026, the difference of selected tier and fulfilled tier will be billed in May 2026 via Blackbaud Tuition Management.**
- St. Veronica Catholic School employs Blackbaud Tuition Management, a tuition management system. Families must register with Blackbaud Tuition Management for tuition collection.
 - If payments are not received by the due date (either the 15th or 30th of each month), a late charge of \$50 will be added to your Blackbaud Tuition Management account.
 - There is a \$50 charge for any returned checks or failed payments handled by Blackbaud Tuition Management tuition.
- There is a non-refundable Registration Fee of \$450 per student at the time of registration. This fee covers: ACRE / ARK, and STAR testing, SchoolSpeak, Virtus, CTN, Extended Care Registration, Curriculum / Instructional materials, Student Insurance, Administrative fees, and Technology fees.
- Mandatory Men's Club dues (\$75) & Women's Guild dues (\$125) will be billed through Blackbaud in the September billing period of the coming school year. Men's Club dues supplement costs related to the Parish Sports Program. Guild fees are raised to fund busses for field trips.
- I understand that I am registering my child/ren for the entire 2025-2026 school year, and that a spot at St. Veronica Catholic School is therefore being held for my child/ren. Tuition is collected over a twelve (12) month period (July 1, 2025 - June 30, 2026) with the exception of families that have a child in 8th grade. **Tuition for all 8th grade students is collected over a ten (10) month period (July 1, 2025 - April 30, 2026). All 8th grade tuition fees must be current before graduation.**
- At the end of each trimester the principal will consider the possibility of dropping the student(s) from enrollment for the following trimester or school year if they meet the following criteria:
 - Are delinquent in their tuition account.
 - Have made no effort to discuss and correct the problem with the principal.

In the event that a family is removed from the school at the end of a trimester for non-payment of tuition, past-due tuition through the end of that trimester will remain payable and tuition already paid is not refundable. Parents will be held responsible for reasonable attorney's fees and collection costs necessary for the collection of any amount not paid when due.
- Families leaving St. Veronica Catholic School during the 2025-2026 school year are responsible for tuition for the entire month in which they leave.
